# 1. Confirmation of Chair's appointment

Diana Kloss welcomed everyone to the meeting and thanked the Directors for confirming her appointment as Chair of the Council for Work and Health for the next three years. Diana took this opportunity to congratulate all those elected as Directors.

#### 2. To note membership of the Board of Directors

Diana Kloss was appointed Chair of the Council following a teleconference held by the Directors on 3 May 2013.

## 3. To note timetable of future elections

It was noted that three directors would be appointed for three years, and two directors appointed for two years to aid with continuity and succession planning. #### 4. Annual Report

Diana Kloss gave a brief overview of the activities of the Council for Work and Health during the past twelve months (copy attached to these minutes).

#### 5. Financial Statement

An income and expenditure report from 1 January 2013 - 30 April 2013 was tabled. It was noted that a donation from COHPA for £6,000 had been received and thanks were expressed to COHPA for this generous gift of funding for the Council for Work and Health.

It was noted that the current bank balance was £11,437.

#### 6. Appointment of an Accountant and/or Auditor

It was noted that the Faculty of Occupational Medicine had produced the income and expense reports for the Council for Work and Health. However, as the Council was now a Company Limited

by Guarantee there were additional legal and financial responsibilities in submitting timely returns to Companies House the Inland Revenue and the Faculty stated it was not able to assist with more formal accounts. The Faculty was thanked for all their help.

Member organisations were asked to let the Secretariat know if they were able to offer assistance with the Council's accounts. An accountant would be sought, but would have to be paid. There was no legal obligation to submit accounts to Companies House until October 2014. As a small company there was no legal obligation to have the accounts audited.

### 7. Any other business

Mike Goldsmith requested that a full budget be produced for 2013-14 as the COHPA Board had asked how their donations were being used. It was agreed that this would be discussed at the full Council meeting to be held immediately after the AGM.

The meeting concluded at 1330.
